Background:

The financial sector in India has been rapidly integrating with global processes and systems and is not immune to global challenges. While the Indian financial sector has made great strides such as in payment ecosystem, there is a growing realization on the importance of fostering interaction between academicians, bankers, stakeholders and regulators who have played a critical role in the recent financial crisis.
